## TERMS & CONDITIONS

EMDR-A: Part I - Foundations and Core Principles

### Acknowledgement and Agreement:

By completing the registration process, I, the participant, affirm that I have read, understood, and agree to the following terms and conditions.

---

### 1. Registration, Program Access, and Refund Policy

- **Program Format and Access:**
  - **Delivery:** The program will be delivered live, with recordings posted on the online platform after each training weekend. Full live attendance is encouraged but not mandatory.
  - **Recording Access:** Recordings will be available on the online platform approximately one day after the live event.
  - **Course Materials:** The course materials will be provided as a **downloadable e-book for personal and professional use**, available on the online platform in mid-April 2026.
  - **Platform End Date:** Access to the online platform, including all video recordings, materials, and quizzes, will be granted until January 7, 2027.
- **Refund Eligibility:** Participants may request a refund at any time prior to the release of course materials. Approved refunds will be issued minus a **\$100 administrative fee**, which covers payment processing and registration-related administrative costs.
- **After Course Materials Are Released:** Once course materials or other training content have been made available on the training platform in mid-April, all sales are final, and refunds will not be issued, regardless of participation, attendance at live or hybrid sessions, or completion of the training.
- **Payment Plans:** Participants who select a payment plan agree to complete all scheduled payments. Payment plans represent a commitment to the full course fee. Once course materials have been released, all remaining scheduled payments remain due and are non-refundable. Participants utilizing a payment plan must ensure payments remain current to maintain continuous access to the online platform.
- **Access and Use of Training Materials:** Training materials, recordings, and course content are provided exclusively for registered participants. These materials may not be copied, reproduced, distributed, or shared without written permission.

## 2. Course Completion Requirements

### 2.1. Completion Criteria

To successfully complete the course, participants must:

- View all required content.
- Achieve a minimum score of 75% on each of the six session quizzes. Three (3) attempts are permitted per quiz.

### 2.2. EMDRIA Education Credits

EMDRIA education credits are exclusively restricted to participants who have successfully completed an EMDRIA-Approved Basic EMDR Training.

## 3. Eligibility and Prerequisites

- **Part I Enrollment:** Students, EMDR clinicians, and non-EMDR clinicians are all eligible to enroll in Part I of the EMDR-A training.
- **Part II Progression:** Progression to Part II is strictly contingent upon the successful completion of both EMDR-A Part I and an EMDRIA-Approved Basic EMDR Training.
- **Required Basic Training Certificate Details:** To qualify for Part II, the Certificate of Completion for the EMDRIA-Approved Basic EMDR Training must clearly include the following:
  - Name of the EMDRIA-approved training provider and the training organization (if applicable).
  - Total number of training hours completed.
  - Date of completion (month/day/year).

## 4. Student and Non-Profit Agency Discounts

To receive the applicable discount code before purchasing Part I - Foundations and Core Principles, the required documentation must be emailed to [admin@emdrcenterofcanada.com](mailto:admin@emdrcenterofcanada.com).

- **Students:** A letter from the registrar confirming current full-time student status.

- **Non-Profit Agency Employees:** A letter from the employer, on the Agency's official letterhead, confirming employment.
